OF THOSE WHO SHARED THEIR DEMOGRAPHICS, 76% BLACK, 3% MULTIRACIAL, 15% CAUCASIAN, 4% HISPANIC, 1% ASIAN AND 1% AMERICAN INDIAN OR ALASKAN NATIVE. 81% OF THOSE WITH DEMOGRAPHIC INFORMATION REPORTED SELF-IDENTIFIED AS LOW INCOME, ATTENDED TITLE 1 SCHOOLS AND/OR RESIDED IN ZIP CODES WITH LOW MEDIAN INCOMES IN ALIGNMENT WITH THE ORGANIZATION'S GOAL TO ALLOCATE ITS RESOURCES TO HISTORICALLY MINORITIZED COMMUNITIES. (PLEASE NOTE - AS WAYM MOVES TOWARDS MORE EQUITABLE PRACTICES, DEMOGRAPHIC INFORMATION IS NOT REQUIRED FOR YOUTH TO PARTICIPATE IN PROGRAMS).
